

# Home Weatherization for Income Qualified Customers Application Form

The JCP&L Home Weatherization for Income Qualified Customers program provides energy conservation measures to income-qualified families living in the state of New Jersey at **no cost**.

For your household to be eligible, you must meet at least one of the two following requirements:

- You must provide proof of participation in the New Jersey SHARES (NJ SHARES) federal/safety net partnership program, or
- Your household income is above 250% and below 400% of the Federal Poverty Guidelines (see the chart for 2025 income levels).

If you meet at least one of the requirements above, you must then meet all of the following criteria:

1. Be an active JCP&L residential customer, and
2. Reside in a single-family home with up to a 4-unit dwelling, and
3. Own the home or have property owner authorization (Renters/Tenants: see Landlord Consent & Permission Agreement), and
4. Own or rent for at least 1 year in a home that is 5 years or older and not under a builder's warranty.
